### Zoning News about the Braun/Cavey Farm

At the Planning Board hearing on March 2nd, the Planning Board voted unanimously (in a non-binding recommendation) against the petitioner's request to rezone the property located directly across from the northern end of Wesley Lane (the southwest corner of the Route 100/103 interchange) from residential zoning (RSC) to commercial zoning (a combination of CCT and POR).

At the Zoning Board hearing on April 19, 2006 the petitioner's lawyers presented most of their case. Because there was not enough time for them to finish or for those of us in opposition to testify, the case has been continued to May 3, 2006 at 7:00 pm.

The Zoning Board's decision is the final, and binding decision on this matter. It is extremely important for us to have a large turnout at this meeting. There is no need to testify at the hearing (unless you want to). Merely having a large number of supporters helps our case. If you do not want to testify, all you have to do is sign in on the "opposing" sheet. Even if you cannot stay for the entire hearing, coming by to sign in is a great help. Please be there to show your support for keeping our neighborhood residential!

# **Mandatory Outdoor Water Restrictions**

All of Howard County will be under mandatory water restrictions on outdoor water use from May 1, 2006 through September 1, 2006 while major water main repairs are underway.

Residents with an EVEN numbered street addresses will be allowed to use water for outdoor purposes on even numbered calendar days ONLY. Correspondingly, ODD numbered street addresses will be allowed to use water for outdoor purposes on odd numbered calendar days ONLY.

### **Spring Cleanup Tips**

- 01. Trim the small saplings from the bottom of hardwood trees; trim branches below 6.5 feet from the ground
- 02. Replace/refresh mulch and edge grass around trees and gardens
- 03. Plant spring flowers
- 04. Clean and paint exterior trim and foundations
- 05. Clean mildew from steps and siding using a stiff brush or power washer
- 06. Power wash decks and fences
- 07. Stain or seal decks and fences
- 08. Top dress and seed lawns then cover with straw or peat moss
- 09. Cut grass at 3-4 inches to promote drought tolerance
- 10. Trim grass at foundation of house
- 11. Repair/replace rotten wooden trim
